Artist/Group will NOT be guaranteed a Slot on stage performance unless full payment is made. Onsite or same day registration is \$300 for 2 days

Additionally, Artists may submit a giveaway items and advertisements for inclusion on tournament souvenirs display tables. This is a free way to advertise yourself or group to the teams/spectators attending each event.

This agreement is for a slot on stage performances. **Artist or group is guaranteed 15/20 minutes of celebrity on stage performance(s).** However, artist or group may have more chances for on stage performances at the options of the event Stage Manager or Directors. On Stage performances are restricted to the above described songs/activities at the option of Stage Director. No exceptions.



Slot on stage performance is limited and thus, guaranteed on a first-come, first-serve basis.

The Community Cup USA Event Managers and the tournament's host reserve the rights to control or halt any activities by any Artist or group for any violation of the rules and regulations of on stage performances; and respective complex policies. Artist or group and authorized personnel agree that they have read, understood; and will comply with the attached rules and regulations for slot on stage performances as evidenced by the artist's or group's signature below.

Rules and Regulations for a slot on stage performance

1. Each artist or group should please return the following items:
 - a. A completed and signed application
 - b. A money order in the amount of \$250 for two days slot on stage performance must, made payable to **Community Cup USA**.
 - c. **Artist or group may register and pay online for a Slot on stage performance**
 - d. Artist or group must secure and maintain liability and rental insurance for the duration of the tournament.
 - e. Must return or submit all required items by email at least 2 days prior to the tournament starting date to the email address listed above. No refunds will be given after this date.
 - f. **Artist or group agrees to promote the community cup usa soccer tournament games and live music fundraising event on his or their websites; send out emails, Instagram and tweet blasts,**
2. **Artist or group is guaranteed 15 to 20 minutes of a slot on stage performance(s)**. However, Artist or group may have other chances to on stage performances at the options of the tournament event stage managers or directors.
3. All decisions by the Community Cup USA Event Managers Directors or the tournament hosting organization are final
4. Driving a vehicle on any grassy area is strictly prohibited without permission.
- 5 The following is not tolerated at the event site:
 - a. Smoking, excluding designated areas
 - b. Pets, excluding service animals
 - c. **Firearms or weapons of any kind, excluding event security and local police**
6. All booths must be freestanding, no stakes or guidelines unless pre-approved by Community Cup USA officials or the tournament hosting organization.



7. The Community Cup USA Event Managers and the tournament hosting organization reserve the rights to restrict exhibitions with respect to methods of operation and display of materials. The Community Cup USA Event Managers and the tournament hosting organization reserve the rights to remove from the event venue any artist or group without refund if they determine the artist or group is not respecting other artists/groups or not adhering to the rules herein stated. If, for any reason, an artist/group or his/their songs or activity contents are deemed objectionable by The Community Cup USA officials or the tournament hosting organization, the artist or group will be removed from the stage or event grounds without refund. All decisions by the Community Cup USA Event Manages Directors or the tournament hosting organization are final.

Artist or group may be removed at once from event grounds and/or banned from this event and future tournament events if:

- 8. The Artist or group conducts are damaging or detrimental to the best interests of this event;
- 9. The Artist or group violates any of the rules or regulations of this event.
- 10. The artist or group brings any controlled substance, weapons of any kind or dangerous items to the event grounds.
- 11. The artist or group uses foul or offensive obscenities.
- 12. **The artist or group engages in belligerent, fighting or violence of any kind .**
- 13. The artist or group agrees to hold harmless and indemnify the Community Cup USA, the tournament hosting organization, its committees, officers, agents, employees, and representatives, the owners of the cedar lane sport complex in which the tournament event is being held; from any claims, including theft, damage, loss or injuries of any kind.
- 14. The Artist or group concur that they have read and understood the rules and regulations outlined herein; and it is agreed that these rules are part of this contract and no other agreements whether verbal or written, implied or expressed, shall be binding upon the parties unless in writing and signed by the Community Cup USA Event managers, Directors and/or the tournament hosting organization.
